

COVER IT, WAYNE COUNTY!

This is an application for cost share through the *Cover it, Wayne County!* Clean Water Indiana grant, awarded to the Wayne County SWCD in 2025 by the Indiana State Soil Conservation Board. Eligible practices for cost share are Cover Crops and Pollinator Habitat.

Cover Crop rate not to exceed \$30/acre, up to 75% of total cost, capped at \$10,000 per landowner, with approved seeding prior to planting and seed tag verification.

Pollinator Habitat rate not to exceed 75% total cost, capped at \$1,000 per landowner, with approved seeding prior to planting and seed tag verification that seed is free from all amaranths, noxious, and invasive species.

All installed practices approved for cost share shall be field verified by SWCD or NRCS technical staff before payment is made.
